3. PUH w/tbg to 400'. Ppd 89 sx Class "B" cmt dwn tbg & est circ out bradenhead.
4. Displace cmt w/9.5 BW @ 500 psig. Ran out of cmt. WOC 24 hrs.
5. DO cmt. Press tstd csg & est circ out bradenhead @ 0.5 BPM & 700 psig.
6. Ppd 5 bbls red dye dwn tbg followed by 225 sx Class "B" cmt. Flushed w/5 BW. Had full returns out bradenhead w/red dye. Sqz'd lk to 700 psig. WOC.
7. DO cmt & press tst csg to 500 psig, held OK.
8. TIH & CO sd. Pull RBP.
9. RWTP.
