Spudded 12-1/4' hole on 12/2/77. Drilled to 310'. Set 8-5/8" 24# K-55 casing at 258' with 250 sx Class "B", 2% CaCl₂. Circulated 50 sx cement. Tested to 600 psi; held OK.

Drilled 7-7/8" hole to a total depth of 4150'. Set 4-1/2" 11.6# K-55 casing liner at 4150' with 1100 sx Class "B", 50:50 Poz, 6% gel, 2 lbs. medium Tuf Plug per sx. Tailed in with 100 sx Class "B" Neat. Circulated 50 sx good cement.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
