Fraced with 378,000 pounds sand and 195,300 gallons frac fluid. AIR 40 BPM. ATP 2090 psi. ISIP 1700 psi. 15 minute SIP 1500 psi flow back 65 psi. Cleaned out sand.

Set 2 3/8" J-55 tubing at 4287'.

Instructions
