Spudded 12 1/4" hole on 10/5/77. Drilled to 277' and set 8 5/8" 24# K-55 casing at 277' with 250 sz Class "B", 2% CaCl₂ cement. Circulated good cement. Ripped up BOP and tested to 600 psi, held OK. Drilled 7 7/8" hole to a total depth of 4440'. Set 4 1/2" 10.5# K-55 casing at 4432' with 1180 sz Class "E" 50:50 Poz, 6% Gel, 2 lbs. medium Tuf Plug per sz. Tailed in with 120 sz Class "E" Keat. Did not circulate cement.

Instructions
