Completion operations began on 12/3/77. Ran 2-3/8" tubing and cleaned out to PBD of 4409'. Pressure tested casing to 3400#; held OK. Perforated 4077-92, 4098-4110, 4142-64, 4234-4334. Foam fraced in two intervals with 1718 bbls. water, 2,564,200 SCF of N₂ and 400,000 lbs. sand. Production tubing landed at 4338'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
