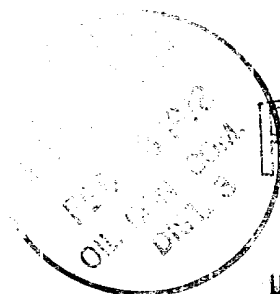

Completion operations began on 1/4/78. Tripped in hole with tubing and drilled cement to PBD of 4420'. Pressure tested casing to 3400 psi; held OK. Perforated 4091-4108', 4132-68, 4226-38, 4252-4334. Foam fraced in two stages with approximately 1,700 bbls. water, 2,500,000 SCF of N₂ and 400,000 lbs. sand. Cleaned out sand. The 2-3/8" production tubing was landed at 4342'.

Instructions
