

## SITE SECURITY PLAN

1. All appropriate valves and connections on lines entering or leaving oil storage tanks will be effectively sealed using numbered seals which may not be removed without being destroyed.
2. A record of the numbered seals will be maintained showing when they were installed and when they were removed. This record will also identify the valves and connections to which the seal numbers apply and will be available for inspection by Minerals Management Service personnel on request.
3. Oil storage tanks will be gauged at least every other day. Measurements will be recorded and these records will be made available for Minerals Management Service review on request.
4. Visual inspection of oil production and storage facilities will be made at least every other day. These inspections will be documented and the documentation will be made available for Minerals Management Service review on request.
5. An appropriate site facility diagram has been, or will be, timely filed with the Supervisor.
6. Accumulations of oil will be sold in a timely manner. Marketable oil will not be removed from storage tanks without going through the sales line, unless otherwise approved by the Supervisor.
7. Slop or waste oil will be dealt with promptly and in accordance with applicable regulations, operating orders and/or notices to lessees.
8. Storage facilities will be clearly identified with a sign that contains the name of the operator, the lease serial number, and the applicable quarter-quarter section, township, range and meridian. Signs applicable to facilities on Indian leases will include the name of the appropriate Tribe or Allottee.
9. Each individual storage tank will be clearly identified by a unique number. The identification will be maintained in legible condition and will be clearly apparent at the sales point.
10. Operator is informed that the transporter and/or purchaser of oil production from this property is/are aware of, and intend(s) to comply with, all requirements for proper identification documentation applicable to crude oil removal from Federal and Indian oil and gas leases.

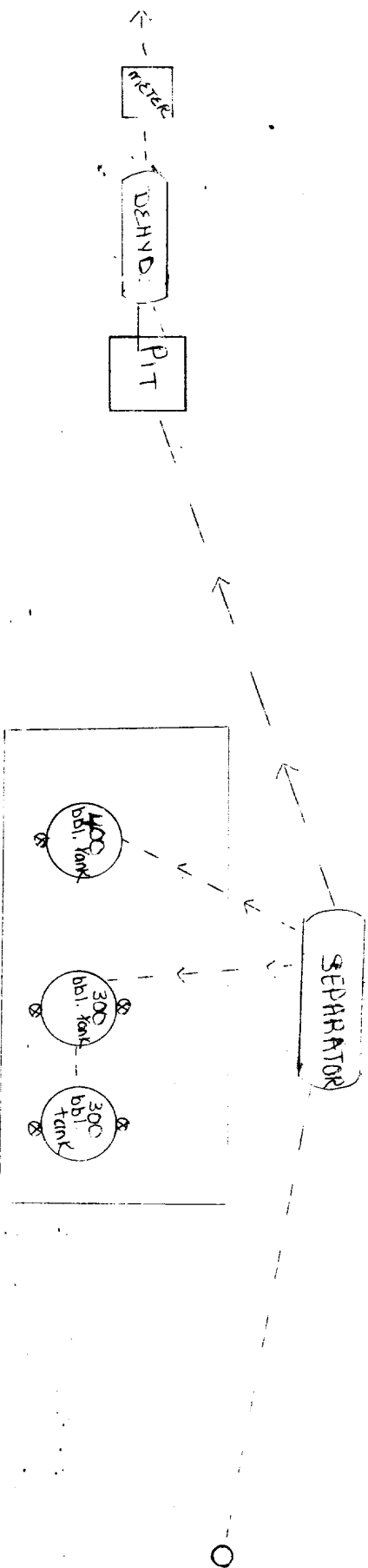
# SITE SECURITY DIAGRAM
