11/23/78: PBTD 7959'. Tested casing to 4000#, OK. Perfed 7725, 7732, 7738, 7746, 7753, 7852, 7859, 7886, 7895, 7906, 7911, 7924, 7943, 7923 with 1 SPZ. Fraced w/93,000# 40/60 sand and 97,500 gallons slick water. Flushed w/5500 gal. water.
