INSTRUCTIONS

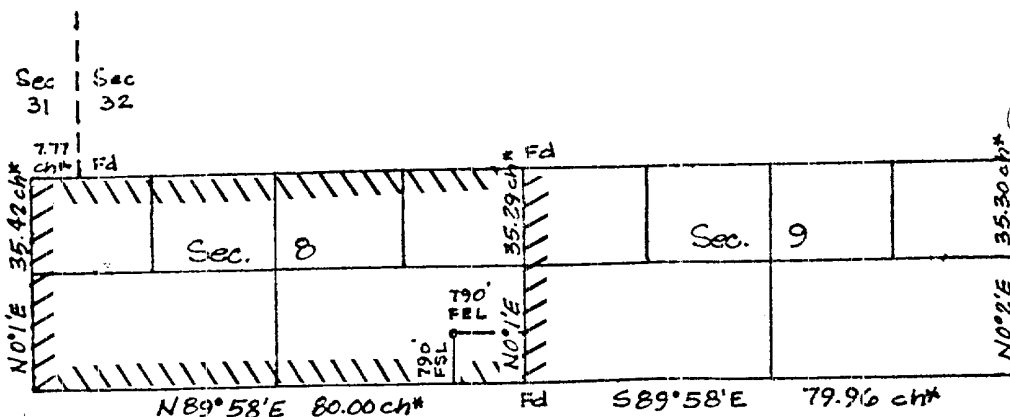

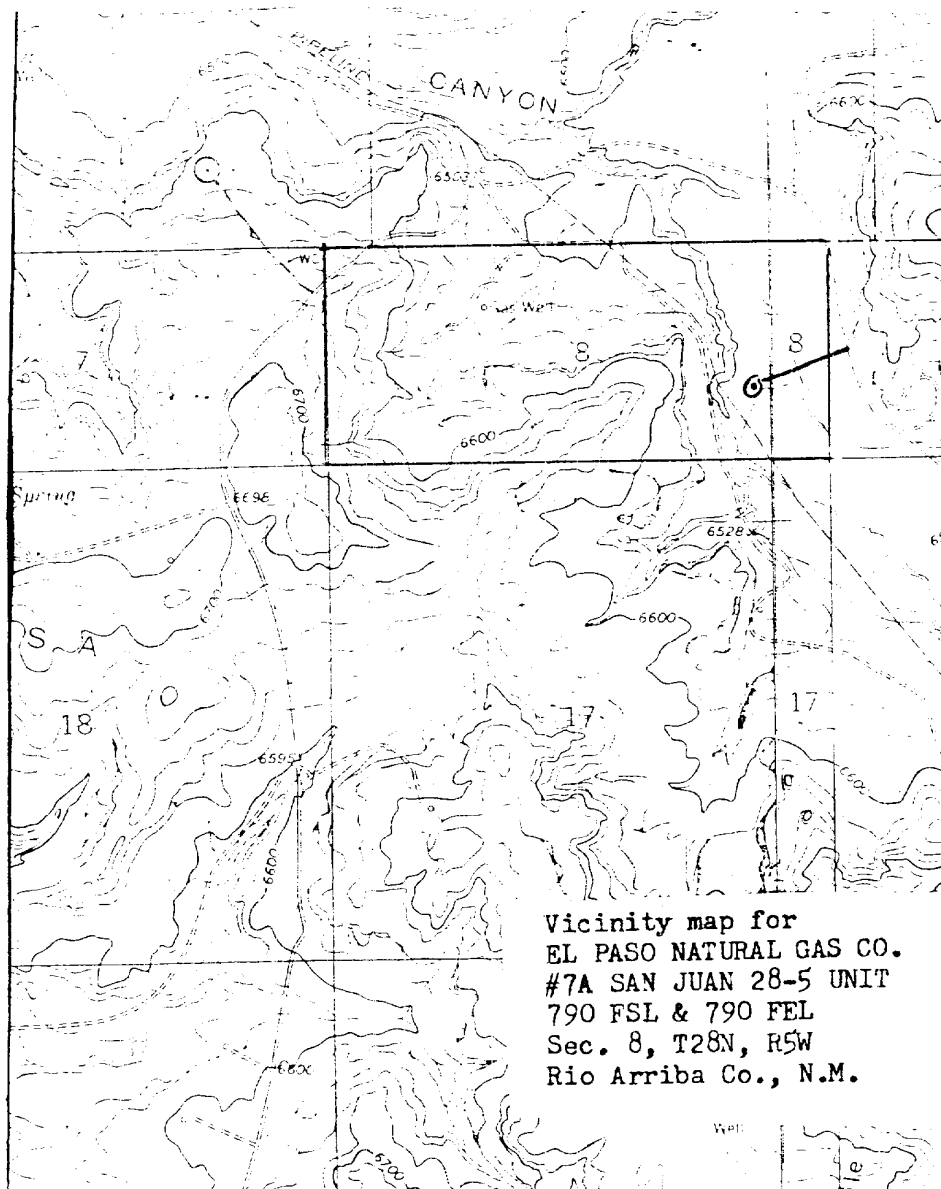
