



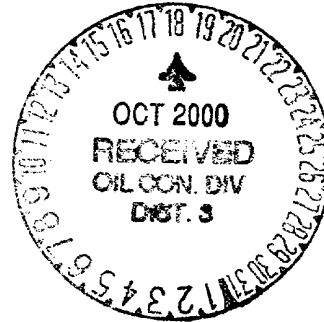

Dear Ms. Marberry:

Reference is made to your recent application for an amendment to Division Order No. DHC-2720 dated April 24, 2000, which order authorized the downhole commingling of Blanco-Mesaverde and South Blanco-Pictured Cliffs Gas Pool production within the well, to add the Otero-Chacra as a third commingled zone in the well.

It appearing that the subject well qualifies for approval for such amendment pursuant to the provisions of Rule 303.C., and that reservoir damage or waste will not result from such downhole commingling, and correlative rights will not be violated thereby, you are hereby authorized to commingle the production as described above and any Division Order which authorized the dual completion and required separation of the zones is hereby placed in abeyance.

The maximum amount of gas which may be produced daily from the well shall be determined by Division Rules and Regulations or by the gas allowable for each respective prorated pool as printed in the Division's San Juan Basin Gas Proration Schedule.

Production from the well shall be allocated as follows:


Oil and gas production from the Blanco-Mesaverde Gas Pool shall be determined by utilizing the production forecast submitted as an attachment to the downhole commingling application. Oil and gas production from the Otero-Chacra and South Blanco-Pictured Cliffs Gas Pools shall be

determined by subtracting Blanco-Mesaverde Gas Pool production from the well's total monthly oil and gas production. (Note: Subsequent to completion and production testing, the applicant shall consult with the supervisor of the Division's Aztec District Office in order to establish a fixed allocation of production for the Otero-Chacra and South Blanco-Pictured Cliffs Gas Pools. After approval by the Division's Aztec District Office, the applicant shall provide this fixed allocation to the Santa Fe Office of the Division.)

Pursuant to Rule 303.C.(2), the commingling authority granted herein may be rescinded by the Division Director if conservation is not being best served by such commingling.
