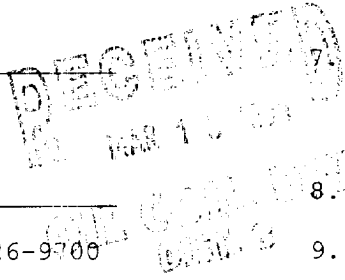

Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 10 pps Gilsonite, 0.5 pps Flocele (127 cu.ft.). Displace w/141 bbl wtr. Circ 20 bbl cmt to surface. WOC.
- 2-12-99 WOC. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
- 2-15-99 Drill to TD @ 7910'. Circ hole clean. TOOH.
