Cmtd w/403 sx Class "B" neat cmt w/3% sodium metasilicate, 0.5 pps Flocele, 10 pps Gilsonite (1173 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/0.5 pps Flocele, 10 pps Gilsonite, 2% gel (127 cu.ft.). Circ 2 bbl cmt to surface. WOC.

10-3-98 PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

10-6-98 Drill to TD @ 8581'. Circ hole clean. TOOH.
