12/2/00 - Ran 6 joints of 9-5/8" (36#, J-55) casing in 12-1/4" hole. Set shoe at 283.7'. Cement with 150 sk Type III with 2% CaCl2 and 0.25 lb/sk Cello Flake. Displaced with 19 bbl water, returned 14 bbls to surface. Bumped plug with 400# psi at 5:40 pm.

12/5/00 - Ran 76 joints of 7" (20#, J-55) casing in 8-3/4" hole. Set shoe at 3159'. Cement with 416 sk Prem Lite with 2% CaCl2 and 0.25 lb/sk Cello Flake and 8% Gel. Followed by a tail cement of 86 sk Type III with 2% CaCl2 and 0.25 lb/sk Cello Flake. Displaced with 126.4 bbls and returned 20 bbls to surface. Bumped plug with 1304# psi at 12:30 pm. Floats held.

12/8/00 - Ran 170 joints of 4-1/2" (10.5#, J-55) casing in 6-1/4" hole. Set shoe at 7260'. Cement with 382 sk Prem Lite with 0.25 lb/sk Cello Flake, 0.2%CD-32, 0.65% FL-52 and 0.3% R-1. Displaced with 114 bbls water. Bumped plug with 750# psi at 9:20 pm. Floats held.
