12-11-00 Ran 6 joints of 9-5/8" (36#, J-55) casing, set shoe at 283'. Cement with 150 sk Type III with 2% CaCl₂ and 0.25 lb/sk Cello Flake. Displaced with 18.7 bbls water, returned 12 bbls to surface. Bumped plug at 3:45 pm, with 100# psi.

12-15-00 Ran 81 joints of 7" (20#, J-55) casing, set shoe at 3317'. Cement with 449 sk Prem Lite with 2% CaCl₂ and 0.25 lb/sk Cello Flake. Displaced with 131 bbls of water, returned 13 bbls to surface. Bumped plug at 2:40 am with 1500# psi. Floats held.

12-18-00 Ran 170 joints of 4-1/2" (10.5#, J-55) casing, set shoe at 7320'. Cement with 345 sk 35:65 Type III with 7 pps CSE, 0.1% R3, 0.25 pps Cello Flake, 0.45% CD-32, and 0.65% FL-52. Displaced with 90.7 bbls water, returned 13 bbls cement. Bumped plug at 12:40 pm with 2000# psi. Floats held.
