On 5/20/01, 9-5/8" surface casing was set at 418' KB. The casing was cemented with 300 sx cl "B" cement. 30 bbls of cement was circulated to surface. The BOP's & surface casing was pressure tested to 1,000 psig for 30 min. Held OK. Drilling resumed that night.
