152 jts of 4-1/2", 10.5#, J-55 casing was set at 6,716' KB. The casing was cemented with 200 sx of light weight cement (13.0 ppg, 1.42 cu/ft/sx). The top of cement as reported by temp survey was 4,100' KB.

The rig was released on 6/7/01.

THE PRODUCTION CASING WILL BE PRESSURE TESTED DURING COMPLETION AND WILL BE REPORTED ON THE COMPLETION REPORT AS REQUIRED.
