Cross Timbers Operating Company reached an intermediate depth of 5,010' MD on the above mentioned well @ 8:00 a.m. on 5/16/01.

On 5/17/01, 7" intermediate casing was set at 5,009' KB. The casing was cemented with 600 sx type III/poz/gel cement (11.4 ppg, 2.09 cuft/sx) followed by 200 sx type III cement (13.5 ppg, 1.71 cuft/sx). 53 bbls of cement was circulated to surface. The BOP's & 7" intermediate casing was pressure tested to 1,500 psig for 30 min. Everything held OK. Drilling resumed using air/mist on 5/19/01.
