Cross Timbers Operating Company reached a total depth of 6,870' MD KB (6,753' TVD KB) on 5/21/01.

162 jts of 4-1/2", 10.5#, J-55 casing was set at a depth of 6,852' KB. The casing was cemented with 175 sx of light weight cement (13.0 ppg, 1.46 cuft/sx). A temp survey found the top of cement at 4,250' KB. The rig was released on 5/24/01.

THE PRODUCTION CASING WILL BE PRESSURE TESTED AT THE TIME OF COMPLETION.
