12/29/00 Ran six joints of 7" (20# / J-55) casing, set shoe at 267'. Hole size is 8-3/4". Cement with 75 sk (19 bbls) of Type III cement with 2% CaCl and 0.25 pps Cello Flake. Displaced with 9.2 bbls fresh water and returned 5 bbls to surface. Bumped plug at 4:15 am with 50# psi. Floats held.

01/02/01 Ran 72 joints of 4-1/2" (10.5# / J-55) casing, set shoe at 2947'. Hole size is 6-1/4". Cement with 300 sk 65:35 cement with 6% gel, , 10 pps CSE, 2% CD-32, 0.25 pps Cello Flake, and 0.65% FL-32. Displaced with 46 bbls 2% KCl, returned 8 bbls to surface. Bumped plug at 9:15am with 1220# psi, floats held.
