6/24/01 Ran 77 joints of 7"(20#, J-55)casing. Set at 3250', hole size 8-3/4". Cement with 435 sacks premium lite followed with 81 sacks of type 111 cement. Good circulation with 18 bbls of cement to surface.

6/27/01 Ran 170 joints of 4-1/2"(10.5#, J-55)casing. Set at 7200', hole size 6-1/4". Cement with 381 sacks type 111 cement. No returns to surface. Cement bond log will be run.
