Stage collar at 2087' KB. Cemented through shoe with 95 sx. Cemented through stage collar with 95 sx. Bumped plugs to 1500 psi in both stages, held pressure, released pressure, both floats held. Job completed at 4:50 A.M., 11/23/62.
