DETAILS OF WORK

To drill and test subject well to the Bakota formation. Est. TD - 6590'. Surface Casing: 6-5/8" 24# casing to be set at approximately 275' KB and cemented to surface. WOC 24 hours. Production Casing: 4-1/2", 12.600/ft., J-55 tubing, non-upset, with stage collar set approx. 90' below Picture Cliff. Use centralizers and scratchers thru the Bakota and Gallup Sands. Cement with 300 sac 1:1 Pozmix with 2% Gel on 1st stage and 150 sac Neat cement on 2nd stage. No coring or testing planned. Logging: Combination ES-induction Log from TD to surface casing. Detail ES-induction Log and Sonic or Microlog - 5300' to TD. Run Gamma Ray-Collar Log in conjunction with perforating. Drilling Time: Geologist from 300' to TD. Drift Surveys: At 50' intervals to 300'; thereafter at 250' intervals. Standard Depth Measurements: SLM of drill pipe at approx. 300' above the Lower Gallup Zone, prior to coring or DST, and at TD. Samples: Collect 10' samples from surface to TD, or as directed by wellsite geologist.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

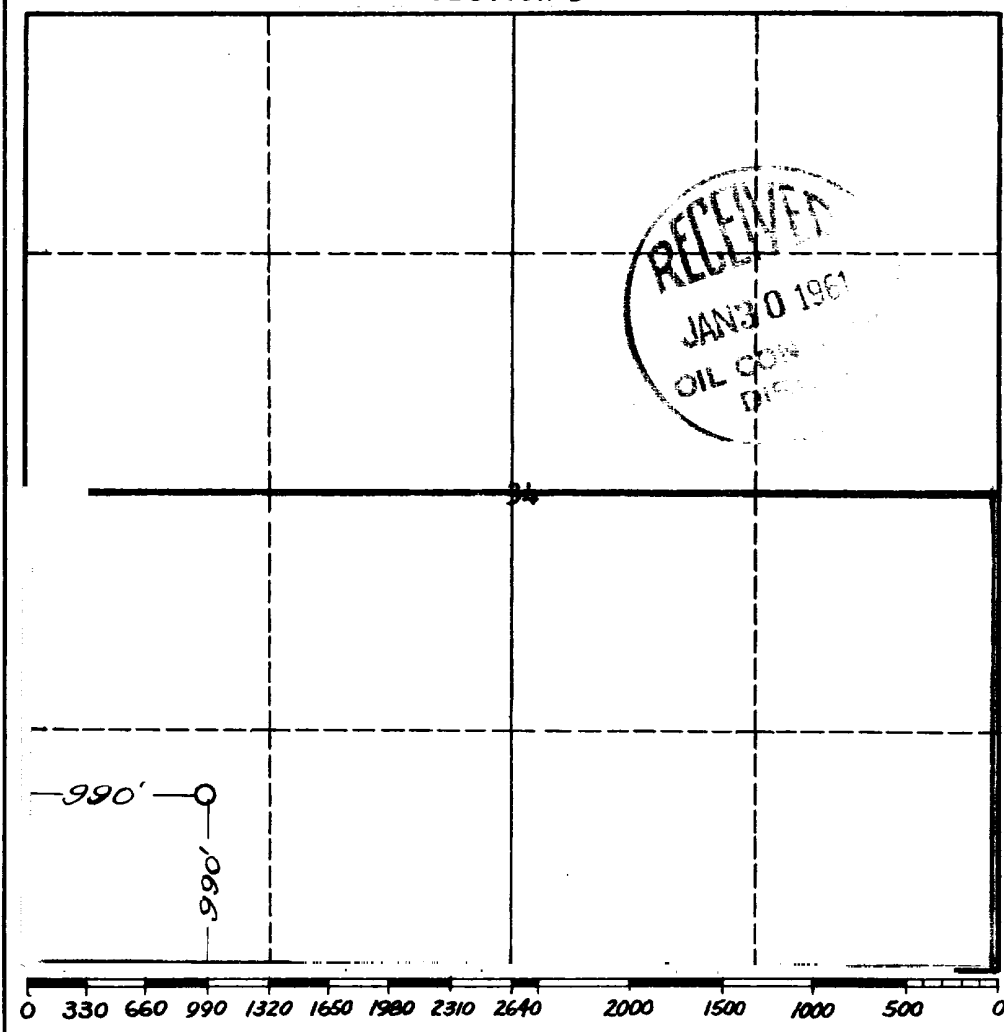
