



13. Describe Proposed or Completed Operations

It is intended to commingle the subject well in the Basin Fruitland Coal (Pool Code 71629) and the West Kutz Pictured Cliffs (Pool Code 79680). The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the work is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.

Notification of the intent to commingle the subject well was sent to all interest owners via certified mail on August 15, 2001. No objections were received.
