Spot 10 sack cement plug 1920 - 2000

Perforate at 1550 and cement with 200 sack 50-50 portmix 25 gal. displace
plug to 1500'.

Perforate and test sands between 1180 and 1460.

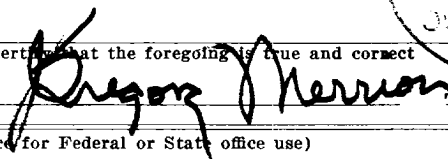
