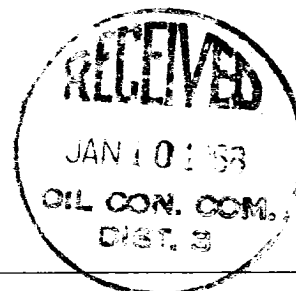

12/21/61 moved in and rigged on casing culling unit. Squashed perforations 4995'-4998' with 15 sacks of common cement with 21 gal. Top of plug at 4845'. Ruled 2-3/8" tubing.

Worked 5-1/2" casing with 150,000 lbs tension. Found free point at 2125'. Shot 5-1/2" casing at 2125'. Spotted 21 sack cement plug from 2175'-2178'. Ruled 51 joints (2119') of 5-1/2" OD, 14.5, J-55, R-3, condition "C" casing.

Plugged in back cement plug in bot of surface casing with dry hole marker. Plug and abandon 1/3/62.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
