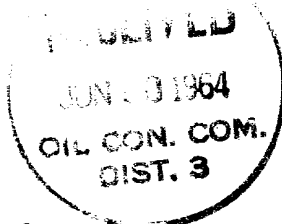

1. Spudded 12-1/4" surface hole 3:30 A.M. May 24, 1964. Drilled to total depth of 320 ft. R.K.B.
2. Ran 11 joints 8-5/8", 24.0#, J-55 casing. Landed at 318 feet R.K.B. Cemented with 250 sacks regular cement with 2% Calcium Chloride. Plug down 10:00 A.M. May 24, 1964. Cement circulated to surface.
3. Nippled up and pressure test surface casing to 800 psi for 30 minutes. Test O.K.
4. Drilled out from under surface casing with 7-7/8" hole.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
