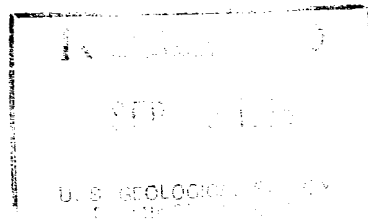

GP-100 wash, cemented w/450 cu. ft. 1:1 Pozmix "S" and Class "A" cement, 1/4# Floccals/cu. ft., 2% gel, 2% calcium chloride. Cemented second stage w/350 cu. ft. 2:1 Pozmix "S" and Class "C" cement, 1/4# Floccals/cu. ft. & 1/4 cu. ft. Strata-Crete "6"/cu. ft., 2% calcium chloride. Cemented third stage w/400 cu. ft. 2:1 Pozmix "S" and Class "C" cement, 1/4# Floccals/cu. ft. and 1/4 cu. ft. Strata-Crete "6"/cu. ft., 2% calcium chloride.

Instructions
