DETAILS OF WORK

1. Cement plug from 1750-1529 with 25 sacks.
2. Out end pulled 21 joints 5 1/2" casing 700'.
3. Cement plug from 750' - 630' with 25 sacks.
4. Cement plug from 65' - surface with 25 sacks.
5. Set 4' x 4" pipe as marker.
