and say as follows:

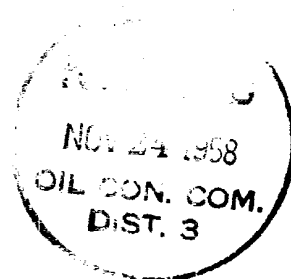
I am an employee of the Guiberson Corporation, and that on

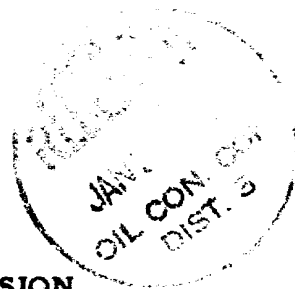

THE APPLICATION OF EL PASO NATURAL GAS COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS BOLACK WELL NO. 14-C, LOCATED 800 FEET FROM THE NORTH LINE AND 1640 FEET FROM THE EAST LINE OF SECTION 30, TOWNSHIP 27 NORTH, RANGE 8 WEST, NMPM, SAN JUAN COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PERMIT THE PRODUCTION OF GAS FROM THE MESAVERDE FORMATION ADJACENT TO THE BLANCO MESAVERDE POOL AND THE PRODUCTION OF GAS FROM THE SOUTH BLANCO-PICTURED CLIFFS POOL.

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION



Under the provisions of Rule 112-A (c) El Paso Natural Gas Company made application to the New Mexico Oil Conservation Commission on November 28, 1958, for permission to dually complete its Bolack Well No. 14-C, located 800 feet from the North line and 1640 feet from the East line of Section 30, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Mesaverde formation adjacent to the Blanco Mesaverde Pool and the production of gas from the South Blanco-Pictured Cliffs Pool.

Now on this 29th day of December, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Sub-section 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, El Paso Natural Gas Company, be and the same is hereby authorized to dually complete its Bolack Well No. 14-C, located 800 feet from the North line and 1640 feet from the East line of Section 30, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Mesaverde formation adjacent to the Blanco Mesaverde Pool and the production of gas from the South Blanco-Pictured Cliffs Pool, through the tubing and the casing-tubing annulus respectively.

PROVIDED HOWEVER, that applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 112-A, as amended by Order R-1214.

PROVIDED FURTHER, that applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test

PROVIDED FURTHER, that applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test as amended by Order R-1214.

PROVIDED HOWEVER, that applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 115-A, as amended by Order R-1214.
