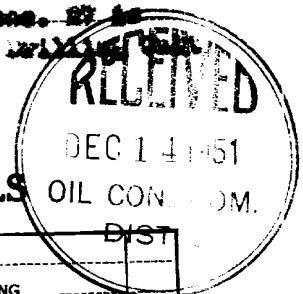

DETAILS OF WORK

It is proposed to drill a well to the Top of Pictured Cliffs Formation with Rotary Tools to est. TD of 2100' as follows:

SURFACE CASING: 10-3/4" OD casing set at 100' and cemented to the surface with 75 sacks cement. Cement to be circulated. WOC 48 hours.

PRODUCTION CASING: 5 1/2" OD casing set on Top of Pictured Cliffs and cemented with 75 sacks of regular Portland cement. Casing to be equipped with Larkin Cement Control Shoe, Larkin Clapper Type F1 Col and 2 Centralizers. Run Temp Surv to loc top of cement. WOC 72 hours.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

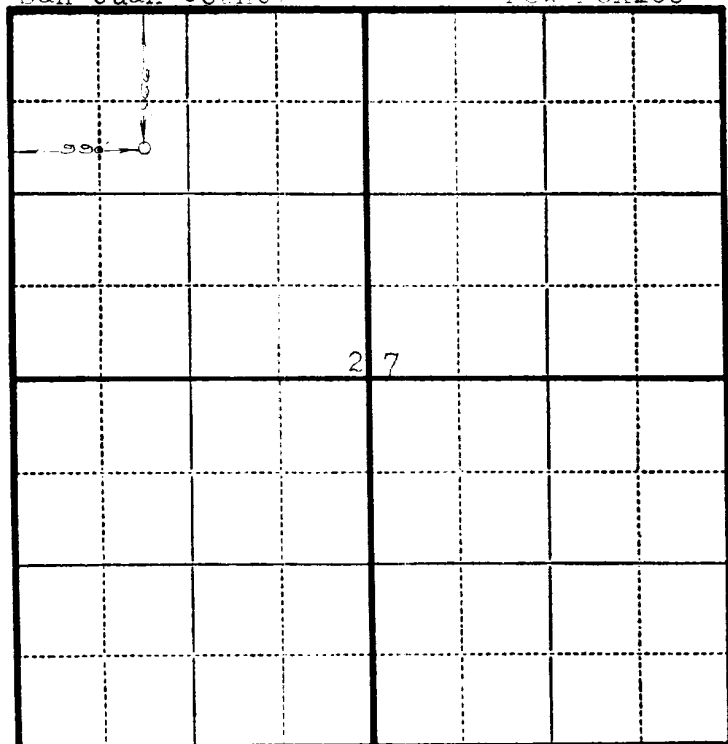
