DETAILS OF WORK

- Due to non-commercial production this well will be plugged & abandoned as follows:
1. Spot a 139' plug from 2275-2136' to cover open hole section 2136' to 2275'.
 2. Determine 6 5/8" casing free point and cut.
 3. Spot a 100' cement plug across cut off.
 4. If 6 5/8" casing cut-off is below 1469', spot a 100' cement plug from 1469-1369' to cover base of Ojo Alamo.
 5. Spot a 10 sack cement plug with a 4" x 4" permanent type dry hole marker in top of surface pipe.
 6. Clean location.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be started.
