DETAILS OF WORK

The well was cased at 12:30 a. m., September 6, 1952. On September 11, 1952, 10-3/4" casing was landed at 358 feet and cemented with 190 sacks of cement. Cement plug down at 4:35 a. m., September 11, 1952. At 12:30 a. m., September 16, 1952, casing and water shut-off were tested at 500 pounds for 30 minutes with no drop in pressure. Forty-six feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 500 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
