DETAILS OF WORK

Well was spudded at 4:00 P.M., August 8, 1951.

On August 9, 10-3/4" casing was landed at 110' with 75 sacks cement. Plug down at 1:50 A.M., August 9, 1951. Located top of cement outside of pipe 42' from surface. Cemented through 1" pipe with 30 sacks outside of pipe. Cemented to surface at 10:00 A.M., August 9, 1951. After 16 hours tested casing with 200 pounds for 30 minutes. No drop in pressure. Drilled 30 feet solid cement. Tested below casing - O.K. Drilling operations were resumed.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
