Holes are suspected in the 4½" casing from 3000' to 4500'. 2-3/8" tubing with a 3-3/4" rock bit will run to PBTD of 6528' to drill and circulate hole clean if necessary. A Baker Model P production packer(2-3/8" x 4-1/2") with dual seal assemblies and a perforated tube bull plugged on bottom will be set at 6435'. Ken pack will be circulated to surface in annular space with 25 barrels being squeezed into holes in pipe, if possible.
