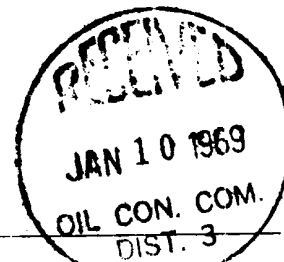

A BAKER MODEL P PRODUCTION PACKER (2-3/8" x 4-1/2") WITH DUAL SEAL ASSEMBLIES AND A PERFORATED TUBE BULL PLUGGED ON BOTTOM WILL BE SET AT 6435' KENPACK WILL BE CIRCULATED TO SURFACE IN ANNULAR SPACE WITH 25 BARRELS BEING SQUEEZED INTO HOLES IN PIPE, IF POSSIBLE.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional preferences and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
