- 2. NUBOPE. POOH w/ 2 3/8" tubing. Drill out CIBP @ 1851'. Drill cement to 2200'. Circ out hole w/air.
- 3. Set CIBP @ 2198'. Perforate Pictured Cliffs 2000'-2120' w/1 jspf. 0/4 ALM
- 4. TIH w/ packer & set ± 1900'. Break down perf w/1000 gal 7 1/2% HCL and ball sealers. Flush w/2% KCL.
- 5. Frac down tubing w/50,000 gal.70 quality foam and 100,000# 20/40 sand.
- 6. Flow/swab well to clean up.
- 7. Release packer. Land 2 3/8" tubing ± 2100'.
- 8. Return well to commingled production.
