Drill down to 1-11-1/2" and run 10' of 1-11/2" casing. Pull slow down; suspect casing leak. Circulate 10' of 1-11/2" casing. Move in workover rig; install BOP; drill and cement with water, as necessary; pull casing. Run casing inspection log to record possible leak(s). Isolate tailup perforations with bridge plug and 1-1/2" casing. Circulate on tubing and establish depth of leading bottom hole. Cement squeeze as ne assure. Drill out casing and cement casing. Circulate test string; if O.K., drill out bridge plug and perforate with production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
