

DETAILS OF WORK

The purpose of drilling this well is to test the **Pictured Cliff** formation, approx. 2000 ft. in depth. One hundred fifty ft. of **8 5/8"** surface pipe will be set and cemented to the surface. If production is found, **4 1/2"**, **11 1/2** lb. pipe will be set through production formation and cemented in place. Pipe will be perforated and sand frac in attempt to produce.


