

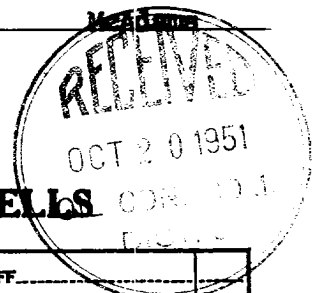

DETAILS OF WORK

It is intended to drill a well with rotary and cable tools through the Pictured Cliffs formation, and to shoot the well with 200 quarts of S.N.G.

Casing Program As Follows:

8-5/8" at 100' with cement to surface.

5-9/16" at 2065' with 100 sacks cement.

NE $\frac{1}{4}$ of Section 20 is dedicated to this well.
