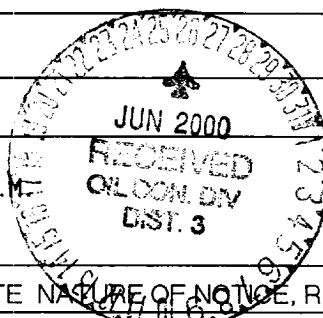

5/17/00 Ran 66 jts 3 1/2" 9.3# J-55 tubing set at 2129'. Cemented with 90 sx 2% econolite, 6#/sk gilsonite, 1/4#/sk flocele followed by 50 sx Class B 4% gel 6#/sk gilsonite, 1/4#/sk flocele and 2% CaC12. (263 cu. ft.) Plug down 4 pm 5/17/00. WOC.
