The reason for abandonment of this Pictured Cliffs sand gas Well is that it has
ceased to be productive. The well was completed January 23, 1959 with total
depth of 1940' & Plug Back to 1864. Surface casing was set at 87' with 50 sx &
5½ casing set at 1910' with 100 sx. Plugs are to be in accordance with U.S.G.S.
as follows;

perforate at 850', squeeze back to 700'
Total Depth to 1750'
Surface plug at 20' & squeeze between 5½ & 8 5/8.
Cut off at ground level or erect dry hole marker.

Instructions
