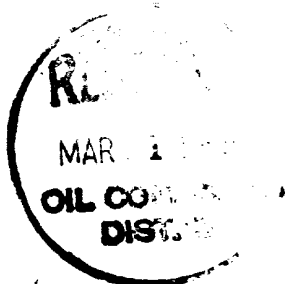

3/3/68 - Acidized 4-1/2" OD Cog. perfs. from 7756' to 7798' with 300 gals. of mud acid, max. press. 23000, minimum press. 16000, avg. inj. rate 6/10 of a bbl. per min. Instant shut-in press. 23000, 5 min. 18000, 10 min. 16500. Held 12500 press. on annulus while acidizing. Seeded 36 bbls. of lead water, 12 bbls. of acid residue & 42 bbls. of stimulation water. No show of gas, not enough oil to get a gravity.
