Production Casing: Ran 213 joints 4-1/2" 10.56 J-55, set at 690'; cemented first stage w/150 sacks 8% gel, 100 sacks Neat. PDB 4:10 A.M., 11-30-63. Pump plug, pressure bled off; float would not hold. Bled back 5 barrels. Replaced volume plug pump. Pump still would not hold. Shut well in for four hours.
Cemented second stage through Baker 2-stage tool at 2286' with 80 sacks 8% gel. PDB 8:15 A.M. 11-30-63.

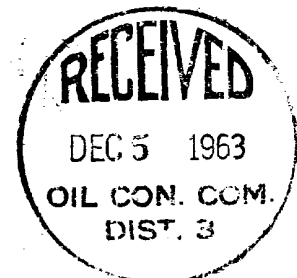

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
