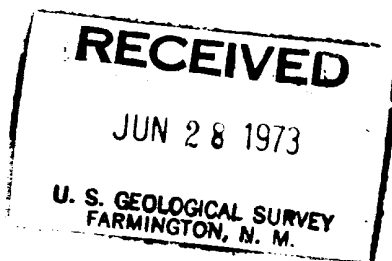

The subject gas well is an open hole completion apparently suffering from caving and water production problems, and the well has never been fracture treated.

To correct this, Amoco proposes to:

1. Run 3-1/2" casing inside the present 5-1/2" casing to TD and cement with 200 sacks.
2. Run a Gamma Ray-Neutron Log and selectively perforate the Pictured Cliffs interval.
3. Acidize and sand-water frac the perforated interval.
4. Return well to production and test.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or Regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
