

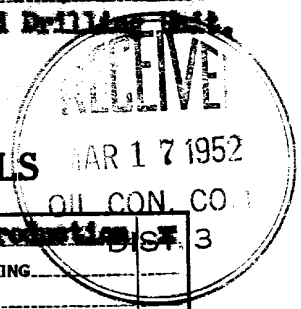

DETAILS OF WORK

- On 1/30/52 ran 70 joints of 5 1/2" OD, 14-H, 14-S, 17-J and 15.5-J, 8 rd. thd., API casing. Total of 2033.5' charged to well with 2018.5' of casing in hole. Set at 2028' EB with 75 sacks of regular cement.
- Moved off rotary tools.
- Moved in cable tools 2/14/52 and drilled through plug.
- Bailed hole dry on 2/15/52. H also stood dry for 30 minutes.
- Drilled to 2085' EB TD.
