Dear Sir:

Mr. Rodney Heath of the Southern Union Gas Company in Farmington informed me by telephone that you wished to have a copy of the shut-in notice on the 5-lb Tonkin well sent to you. He further requested that I give you a brief explanation of the status of the well.

This well was shut in immediately after prorationing went into effect in the San Juan Basin for the reason that we had no file on the well - none of the required forms had been filed, and the 1954 Deliverability Test had not been taken. When El Paso assumed operation of the well they filed the necessary forms and their C-110, Certificate of Compliance and Authorization to Transport Gas, was approved, which gave them permission to put the well back on production. However, the form C-110 showed El Paso Natural Gas Company as the transporter instead of Southern Union, to whose transportation system the well had previously been connected. We just assumed that El Paso meant to have it disconnected from Southern Union's line and take it into their own gathering system.

If this is not the case, then El Paso will have to file another C-110 giving Southern Union as transporter. Southern Union will then get their transporter's copy of the form, which is their authority to put the well back on production.

I hope this is the information you desired.
