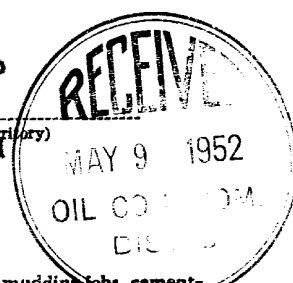
Well will be shot with approximately 150 quarts of nitro glycerine from about 1900' to 1950'.
