Dear Sir:

We have received copies of Federal Sundry Report Form 9331 for the above wells stating that they have not produced for the past year. You further state that each well has a casing leak which you will repair prior to returning to production. You do not however state a time schedule for the accomplishment of these plans. Commission Regulations require that oil, gas and water zones be separated in producing or temporarily abandoned wells in order to prevent the possible contamination of fresh water, and to prevent the possible waste of oil and gas through reservoir damage or thru migration to other porous zones.

You are therefore directed to take immediate remedial action to repair the casing failures in these wells. We are instructing Mr. William Carr, Commission attorney to hold legal action in abeyance for 60 days from this date in order to give you time to take affirmative action.
