13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Work commenced 2/2/99. Attempted to circulate fill out of open hole. Circulating fluid came to surface approximately 3' outside of 10 3/4" surface pipe. Pulled drill string out of well and pumped 6 bbl fresh water down the Braden head between the 5 1/2" and 10 3/4" csg. Water circulated to the surface with no pump pressure. Could not control water coming back due to leak in the Braden head, decided to do Braden head squeeze.

RU BJ Services and pumped 50 sx. Class "H" neat mixed @ 16.4#/gal. down the Braden head. Circulated approximately 16 sx. cement to the surface outside the 10 3/4" csg. WOC for 36 hrs. Tested csg. to 300#, tested okay. Continued with operations as described in Sundry Notice dated 3/18/99.

We apologize for our failure to notify the BLM and obtain approval prior to conducting this unanticipated repair procedure.
