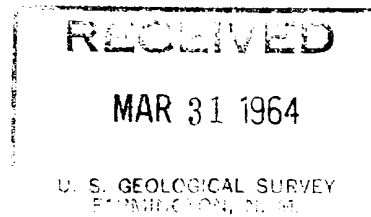

On 3-13-64 this well was plugged and abandoned in the following manner:

Moved unit on location, hit bridge near surface, could not recover tubing, moved rig off location.

Moved workover rig on location and cleaned out to 715' at the bottom of the Ojo Alamo. Ran 23 joints (710') 2 7/8" junk tubing, cemented first stage w/25 sks. regular, second stage w/75 sks. regular, 4% calcium chloride. Pulled 30,000# on tubing. Drilled cement out of tubing and perforated at 709' and pumped in at 1800#. Cemented through perfs w/50 sks. regular. Pumped in at 2000#, held 1000#. Well completed as a flowing fresh water well.

Instructions
